



Tenant Application Steps

Thank you for your interest in our properties! At all GCC properties, rent is due on the first of the month. We look forward to welcoming you as a tenant partner.

Here's how to apply:

- 1. Complete the attached GCC Partners Tenant Application.***
- 2. Please visit our website at www.gccpartners.com for approval criteria. GCC Partners believes in equal opportunity housing.***
- 3. Please complete the application legibly, completely and accurately. Incomplete or illegible applications may be disqualified.***
- 4. Complete the attached Electronic Funds Transfer form. You can use a checking account, credit card or debit card. If using a checking account, please make sure to attach a voided check (or copy).***
- 5. You can mail, email it or fax the application to us. Your \$30.00 per person application fee will be deducted using the information from your completed EFT form. We are unable to accept cash, checks or money orders for application fees.***
- 6. As the final step before approval, we will automatically debit \$500.00 rent pre-payment from your account to hold the property for you. Please do not submit your application if the \$500.00 is not available. A rejected EFT debit will result in automatic disqualification of the applicant.***
- 7. The rent pre-payment is NON-REFUNDABLE as we will remove the property from showing and make it "yours".***
- 8. If approved, we will contact you within 24 hours to give you the good news and arrange the details of your move. The \$500 rent pre-payment secures the property for you for up to 30 days and will be applied to your move-in balance. The balance is due by EFT 24 hours prior to move-in. Regretfully, we cannot accept cash, checks or money orders at move-in***
- 9. If we are unable to approve you, we will not debit your account for any reason.***
- 10. If we are unable to approve you for the home, we will mail a letter to your current address with the details. In these instances, we are unable to leave phone messages with the news in order to protect your rights under the Fair Credit Reporting Act.***

Electronic Funds Transfer Authorization



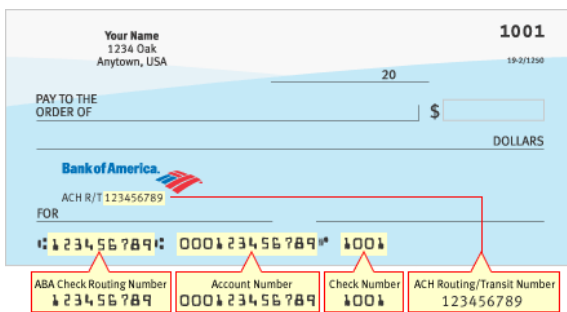

GCC Partners shall incur no liability if the balance in the account of the member is insufficient to cover the EFT or for any reason was not collectable. **There is a \$25.00 service charge for each returned EFT.** I understand that rent is considered late and unpaid if an EFT is returned for any reason. GCC Partners is authorized to withdraw all accrued rent, late fees, rent increases and service charges. This authority is to remain in force and effect until lease expires or the termination is accepted by GCC Partners. I understand that it is my responsibility to notify GCC Partners immediately in writing should I change my account or financial institution. Please allow at least two weeks for updates to be processed.

All transactions with your account shall be governed by the Electronic Fund Transfer Rules and Procedures and the Automated Clearing House (ACH) rules.

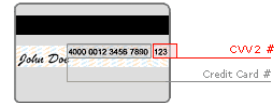
